- 1. Finger save gloves will be legal this coming year.
- 2. The only official referee jersey is black. There are no alternates. If your team wears black you are encouraged to provide the referees with vests of a contrasting color.
- 3. Mandatory Rules Interpretation Meetings will be held annually.

A motion was made to reject the concept of a "mercy rule" and the motion was passed unanimously. The mercy rule as proposed by the state would end the match when one team reaches 10 goals...regardless of how much time is remaining.
