OHSAA President's meeting -

- A) Coaches are requested to rate referees after each game this fall using the on line format. You will need your school code and the referee number.
- B) NEW RULE; Exception #11 If a school eliminates sports, any student will have a free transfer with no penalty to another school to participate in sports. If the school resumes sports, the player is not permitted a free transfer back, no Superintendent's agreement will work.
- C) OHSAA is looking into all sports posting scores after their games.
- D) OHSAA is going to request all rosters be electronically sent to them in order that opposing schools can pull rosters for upcoming games (for programs, etc)
- E) Blue Ribbon committees have been formed to review every rule and policy of OHSAA
 - 1) By-Law review, Dr Debbie Moore chair
 - 2) Interscholastic Athletics 2020, John Dickerson chair Some issues – school funding; impact of club, AAU and Junior Olympic or Olympic Development programs
 - 3) Length of Season, Duane Warns chair

- F) Seniors will NOT count against the 5 player limit on club teams
- G) New physical and consent forms and now available on the OHSAA website
- H) Starting this fall, only OHSAA sanctioned sports will be covered by OHSAA insurance. Indoor track, men's volleyball and lacrosse will not be covered
- I) OHSAA is exploring what to do about private schools and the impact they have on the state tournaments. (EX: in the past 20 years 50% of all titles have been won by private schools but comprise just 12% of the football playing membership)
- J) -OHSAA is looking at he discrepancy in the range of size in division I. It is a much larger range from big to small than any other division.
- K) OHSAA is looking to establish a uniform seeding process for all district boards

Kim Mahoney Respect of the Game award – To be awarded to a coach of a girl's team, the equivalent of the Ron Pinsenschaum award (which will now be for coaches of boy-s teams)
