**A) Membership**

**Banquet**

- Bryan Loveless announced that the State Banquets will be Sunday, December 3, 2006 @ The Buckeyes Hall of Fame – 12:00 p.m. Boys & 4:00 Girls.
- Bryan Loveless and John Johnson are working with the National Office on whom the speakers will be for each banquet.

### **State Clinic**

- John Johnson asked for feedback on what coaches thought about the presenters and the clinic.
- Consensus that the presenters were very good, but some coaches would like a separate fee for each day (Friday & Saturday).
- John reported that there were just under 200 coaches that attended.
- Brian Stevens and John Johnson are going to meet with Coach Bleum in September to discuss the Spring 2007 Clinic.

### **Top Ten Poll**

- John Johnson went over the Top Ten Poll 2006 list (handout voters and procedures).
- Chairs & voters that were present went over list and also discussed nominations and voting.

### **OHSAA Rules Meeting**

- John Johnson presented information in regards to what the coaches will hear at their rules interpretation meetings.
  - A) Officials' Jurisdiction – Officials expected at site at least 15 minutes prior to match. Jurisdiction starts as soon as they arrive.
  - B) Slide Tackles – From the side/studs up is an automatic red card.
  - C) Coaching Area – If not marked as outlined in the NFHS rulebook, then coach must stay in front of bench area.
  - D) Shinguard Rule for 2007 – Must have NFHS logo.
    - John Johnson asked for input on letter to the National Federation on their rationale for this new rule.

### **OHSAA District Tournament Pairings**

- District is on OHSAA website
- Regional draw will be in August
- Still looking for sites to host regional & state matches

### **Website/Treasurer Payment**

There was a discussion about the possibility of a reimbursement for Gene Pitstick (webmaster) and Bob Ellis (Treasurer – taxes and bookkeeper) for their work on behalf of the organization.

### **OHSAA Rule Proposals**

- Soccer Advisory meeting in December. District Presidents are asked to get input from their members. Compile a list prior to the October meeting and get to John Johnson.
- Basketball Coaches Association is proposing using the NCAA rule that allows two hours of instruction per week in the off-season.

### **President's Meeting**

- A) New Ball Contract – Current contract expires after this season. Kim Mahoney will handle the negotiations.
- B) Rating of Officials – Rate after each game. Officials must log information in before coaches can complete their rating. Must be completed by November 25. Should be up and running within a week.

### **Hall of Fame**

- Nominations should be pursued by District memberships.

**Assistant Coach Proposal**

Brian Stevens spoke of allowing assistant coaches beginning in 2007 have one-year free membership. This would help create larger pool of assistant coaches that are members.

**Other Business**

- Members were asked about possible sites within their area that would be good for hosting district/regional/state semi-final matches. We have outgrown some of our existing sites (i.e. Boys Division I State Semi-Final @ Cleveland State).
- Possible sites for future state championships:

  - Ohio State
  - Ohio Wesleyan
  - Capital
- Questions about the possibility, in the future, of separating state championships (public v. private) based on comments from the OHSAA and Commissioner Ross.
